A little over 20% of turnover is made on export. The company, based in Tincques in Pas-de-Calais (62), now employs 300 people and has a turnover of 68 million euros.

The group has 10 production sites, 6 in France, 3 in England and 1 in the Netherlands and employs 1,600 people.
